Subject: Release of Rs. 56.17 Crore as grant-in-aid to Government of Maharashtra towards implementation of Safe City Project for Safety of Women in Mumbai from provision of the Financial Year 2019-20.

Sir,

In continuation of MHA Sanction of even number dated 28.09.2018, I am directed to convey the sanction of the President of India for payment of grant amounting to Rs.56.17 crore (Rupees fifty six crore seventeen lakh only) as the 2nd instalment to the Government of Maharashtra from provision of the Financial Year 2019-20 towards implementation of Safe City project under the Nirbhaya Fund scheme in Mumbai as Central Government funds as per details below:

2. The State Government shall transfer the released amount into the dedicated bank account for the Safe City Project of Mumbai being managed by the State Implementing Agency within 15 days from the date receipt of central share of funds for the project. In case of delay, the State Government shall be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse a copy of release order within 3 days of release of funds, to the Central Government addressed as under:

3. The expenditure may be debitable to Demand no 48 Police; 3601 Grants-in aid to State Governments (Major Head); 08.111 Special Assistance (Minor Head); 06 Schemes Financed from Nirbhaya Fund; 06.05-Grants to States for Implementation of Safe City Projects; 06.05.31 - Grants-in-aid-General, FY 2019-20.

4. The above amounts will be sent through RBI Advisory to the State of **Maharashtra**.

5. The grantee shall ensure that the disbursed funds are utilized as per Safe City Framework & Guidelines and adhere to GFR codal formalities/State procurement norms. The State Government shall furnish utilization certificate for the amount released under this head in form 12-C of GFR 2017 to Ministry of Home Affairs on yearly basis.

6. As per GFR rule 211 (1) the accounts of all grantees shall be made open to inspection by the sanctioning authority and the Internal Audit Wing of MHA, whenever the grantees are called upon to do so.

7. The grant may be released to the State Government immediately.

8. The sanction issues in exercise of the delegated power in consultation with Integrated Finance Division of this Ministry vide **Dy. No. CF3427934/F(IV) dated 05/12/2018**.
