Subject: Release of Rs. 62.89 Crore as grant-in-aid to the State of Uttar Pradesh towards implementation of Safe City Project for Safety of Women in Lucknow for provision of the Finance Year 2018-19.

Sir,

I am directed to convey the sanction of the President of India for payment of grant amounting to Rs.62.89 crore (Rupees sixty two crore and eighty nine lakh only) to the State Government of Uttar Pradesh towards implementation of Safe City project under the Nirbhaya Fund scheme as the Central Government share of funds as per details below:

4	First instalment of total project cost approved for release	104.81
5	Central share of First instalment being released (60% of sl no 4 above -rounded off)	62.89
6	State share of First instalment to be released by State (40% of sl no 4 above-rounded off)	41.92

2. The State Government shall transfer its matching share of funds for first installment totaling to **Rs.41.92 crore**, along with Central share of funds into dedicated bank account for Safe City Project for Lucknow positively within 15 days from the date receipt of central share of funds for the project. In case of delay, the State Government shall be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse a copy of release order within 3 days of release of funds, to the Central Government addressed as under:

3. The expenditure may be debitable to Demand no 48 Police; 3601 Grants-in aid to State Governments (Major Head); 08.111 Special Assistance (Minor Head); 06 Schemes Financed from Nirbhaya Fund; 06.05-Grants to States for Implementation of Safe City Projects; 06.05.31 - Grants-in-aid-General.

4. The above amounts will be sent through RBI Advisory to the State of **Uttar Pradesh**.

5. The grantee (State Home Department) shall ensure that the disbursed funds are utilized as per Safe City Framework & Guidelines and adhere to GFR codal formalities/State procurement norms. The State Government shall furnish utilization certificate for the amount released under this head in form 12-C of GFR 2017 to Ministry of Home Affairs on yearly basis.

6. As per GFR rule 211 (1) the accounts of all grantees shall be made open to inspection by the sanctioning authority and the Internal Audit Wing of MHA, whenever the grantees are called upon to do so.

7. The grant may be released to the State Government immediately.

8. The sanction issues in exercise of the delegated power in consultation with Integrated Finance Division of this Ministry vide **Dy. No. CF3422486/F(IV) dated 25/01/2019**.
